#### Overview:

The cream provides optimal hydration to the skin and with the addition of various natural extracts, it offers a solution to acne problems without having comedogenic effects. Another natural oil added to the day-cream is derived from *Simmondsia Chinensis*, which increases the enrichment of active ingredients due to its similarity to human sebum but also has some sebum-regulating properties. *Opuntia ficus-indica* is high in vitamin E and therefore also has interesting anti-inflammatory and anti-redness properties. In addition, it also acts as an enrichment of antioxidants, vitamins and fatty acids. Last but not least, *Gaultheria procumbens* is rich in BHA (Beta Hydroxy Acid) and offers a natural solution to the well-known and highly effective salicylic acid in the treatment of acne.
