Overview:

The Acne Correcting Gel is a purifying gel that prevents the formation of new impurities and makes existing pimples disappear faster without scarring. It has a proven anti-bacterial effect against the bacteria that can cause acne. The combination of active ingredients results in a complete approach. Thus, they reduce sebum production, work exfoliating, have an anti-bacterial effect and promote skin recovery.

Active ingredients:

Monolaurin (coconut extract) is active against *C. Acnes*, the bacteria involved in acne.

Niacinamide or vitamin B3 has antioxidant and anti-inflammatory properties. Moreover, it also reduces sebum production and hyperpigmentation that may remain after acne. It also improves the skin barrier by increasing collagen and ceramides production.

Mandelic acid is an AHA (alpha hydroxy acid) that removes dead skin cells in the top layer of the skin. Thus, it acts exfoliating, causing scars to fade faster and the skin to look more radiant.

Ginger extract contains antioxidants and active ingredients that soothe inflammation. Moreover, it also acts antibacterial. Thus, it helps keep pores clear and fight *C. acnes*.

Aloe vera, derived from the leaves of the *Aloe barbadensis* plant, has soothing and antioxidant properties. In addition, it also stimulates wound healing by boosting collagen production and strengthening the collagen network in the skin.

Wintergreen with natural salicylic acid. Salicylic acid is a BHA (beta hydroxy acid) that is exfoliating. This helps with acne to dissolve clogged pores and remove excess dead skin cells and sebum.

Suitable for vegans.

General properties: The Acne Spot Correction Gel is an effective nutrient composite offering a multi-pronged approach to acne management by addressing the various skin concerns that come with acne. The cosmeceutical blend of monolaurin, coleus oil, policosanol, niacinamide, mandelic acid, ginger extract, aloe vera and salicylic acid not only has keratolytic, anti-bacterial, antiinflammatory,

anti-irritating, and anti-scarring properties, but also has skin regenerating, soothing and moisturizing properties in order to address all possible symptoms of acne. Prevents blemishes and scarring, with ginger extract and niacinamide for normal to acne-prone skin. It reduces sebum production and inflammation while minimizing recurrence of acne break outs. Suitable for sensitive skin.
